



About ZAEM

he Association of Agricultural Economists of the Republic of North Macedonia (ZAEM) is an association of agricultural economists, established with the free joining of citizens, in order to realize and harmonize their professional, scientific and social interests as well as the purpose of performing activities in order to unify and organize its members about the problems associated with the economy in the agro-complex. ZAEM also associates agricultural economists with other interested parties (honorary and accompanying members), to provide advice and ideas on specific economic and political issues in the field of agriculture, food industry, and rural development in the Republic of North Macedonia.

Since its inception in 1997, the citizens are joining ZAEM in order to achieve a wider common interest, which is the development of sustainable agriculture and rural areas in the Republic of North Macedonia.

Objectives and Tasks of ZAEM

The main objectives of ZAEM are:

- Connecting, bringing together, and organizing its members on the issues of economics in the agrocomplex and all areas of its activity; for successful development and increasing the effectiveness in the agricultural economics science, practice, and education;
- Cooperation with governmental and other institutions for solving problems in the area of agricultural economics:

- Works on spreading democracy, pluralism, scientific criticism, and collegial ethics among agricultural economists:
- Keeps and popularizes the history of this profession;
- Collaborates with universities for raising the level of university education, etc.

Activities

The main activity of ZAEM involves the traditional Conference with international participation every two years, which covers various topics in the field of economics in agriculture, rural development, resources, and the environment, food and consumers, agribusiness, etc.

Other activities include organizing forums, seminars, and workshops, as well as conducting training, as well as scientific and professional research. ZAEM participates in numerous national, regional, and international projects, studies, surveys, etc.

ZAEM supports its members to take part in different events and training, especially when organized by other associations of agricultural economists.



History of ZAEM

ZAEM was formed on 6th of March in 1997, as the Society of Agricultural Economists of the Republic of Macedonia.

The association was officially registered on March 9th, 1997.

ZAEM has changed its legal structure on 22nd of September in 1999 to Association of Agricultural Economists of the Republic of Macedonia.

The next legal change was on 10th of December in 2020, when ZAEM has changed its name to the Association of Agricultural Economists of the Republic of North Macedonia.

The Management Structure of ZAEM

The Assembly

The Assembly of ZAEM is the highest hierarchical unit. The ZAEM's Assembly consists of all its members. The Assembly meets at least once a year.

The sessions of the assembly are called up by the President of the Assembly. A session may also be scheduled by the Executive Board of ZAEM or by a written request of one-third of the total number of members of the Assembly. A meeting of the assembly can be called upon a proposal of the Supervisory Board.

The manner of convening the sessions of the Assembly is determined by the Rules of Procedure of the Assembly. As a rule, the Assembly adopts the decisions with the majority of votes from the present members.



Tasting of Young Wines

Since 2012, ZAEM traditionally organizes event for tasting of young wines that are produced in domestic conditions. Wines produced by wineries are not eligible for the event. The event is organized each year i.e. each third week in November. The wine tasting is assessed by a Committee, which is responsible to give assessment grades and recommendations for further improvement of the production technology of the wines.


